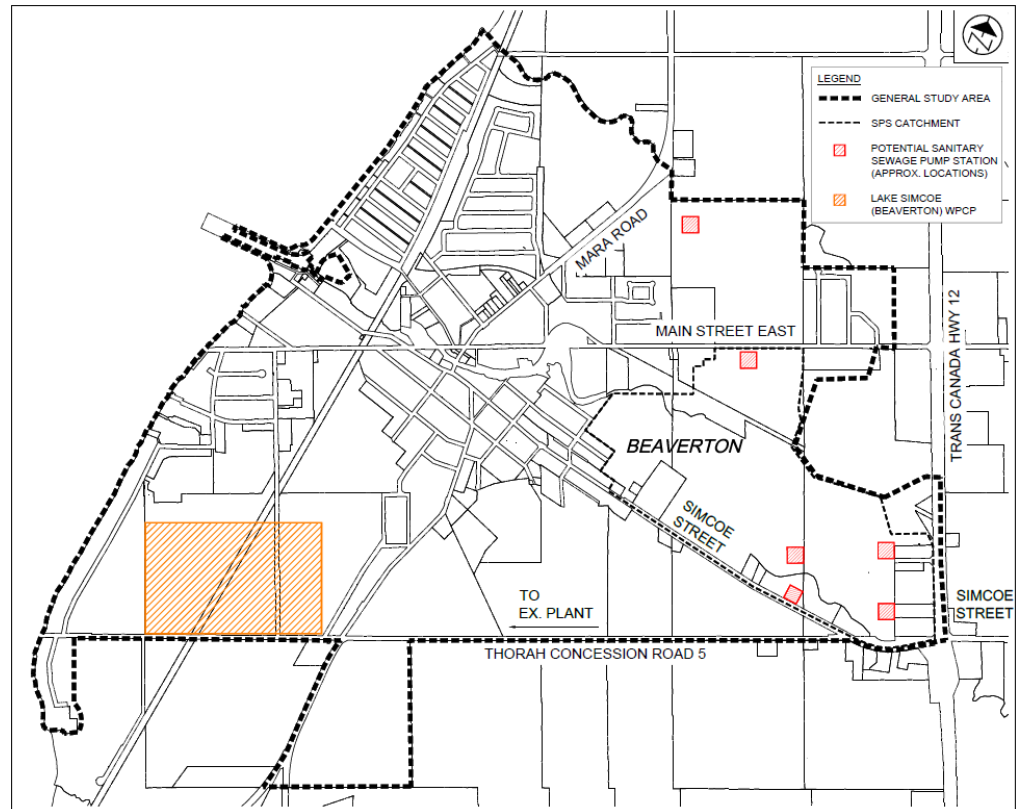

Public Notice

The Regional Municipality of Durham is initiating a Municipal Class Environmental Assessment (MCEA) Study to plan for the sanitary sewage servicing needs of the Beaverton Employment Area, identify and review various alternative sites for the Sanitary Sewage Pumping Station (SSPS), and ultimately select a preferred alternative to allow for existing non-serviced areas to be serviced along with future growth of the Beaverton community.

This Class EA process will follow the planning and design process for Schedule “B” projects as described in the Municipal Class Environmental Assessment Document (as amended March 2023). It is the goal of this study to determine a preferred sanitary servicing plan for the vacant and privately serviced land within the Employment Area.

Currently the Employment Area is largely undeveloped and has no sanitary sewer collection system; existing development relies on private sewage systems.



The Regional Municipality of Durham recognizes that public consultation will be a key component of this Class EA and as such a public consultation process will be developed, including a Public Information Centre (PIC). Upon completion of the study, the Project File documenting the process and outcomes will be available for a 30-day public comment period.
