### Key take-aways from the 2024 Toronto budget plan (thestar.com)

The budget crafted by city staff presented on Wednesday proposes a 2024 spending plan of a whopping \$66.8 billion for city services and capital projects — that's an operating budget of \$17 billion, as well as \$49.8 billion for the 2024-2033 capital budget.
